JUNIATA VALLEY STRIDERS RACE TIMING SERVICE POLICY

The JV Striders provide race timing and finish line services for races in Mifflin, Juniata and adjoining counties within a 25 mi driving distance from Lewistown. Services are provided by explicit agreement with the officers of the club (see below) and must be made a minimum of two months prior to the race date.

Organizations must also provide proof of insurance for the running event. Due to Road Runners Club of America regulations, the Juniata Valley Striders cannot provide timing services for any races not properly covered.

Services provided:

- Use of the club's electronic clock and printout system
- Finish chute and related equipment (results boards)
- Assistance from trained and experienced club members

What is not provided:

- Race bib numbers, results summary
- Race direction, course management, awards ceremony assistance
- Publicity and publication of results (except by special arrangement)
- Anything else not listed above under services provided

Our fees are based on the race distance. Current rates are as follows:

- Up to 15 kilometers (9.3 miles): \$125.00
- Over 15 kilometers to half-marathon or 21K: \$150.00
- Over three hours an additional \$25 per hour

Fees are payable on or before the race date. Special circumstances may apply and affect the rates; please check with the club officers.

Race timing services will be provided upon written (or e-mail) approval after the review of a completed application (attached).
